

**EXTENSION AGREEMENT**

This agreement is made and entered into this 13<sup>th</sup> day of November, 2012, between BOARD OF COUNTY COMMISSIONERS OF SUMTER COUNTY, FLORIDA 7375 Powell Road, Suite 200, Wildwood, FL 34785 (County) and Page Dixon Chandler Smith, LLC (Independent Contractor).

WHEREAS, the parties executed an agreement dated October 1, 2010, for residential and commercial plan review and inspection services. The agreement has an option to renew for two additional one year periods.

WHEREAS, the County desires to renew this agreement at this time under the same terms and conditions as the initial term with the additional condition below:

E-Verify: system established by the U.S. Department of Homeland Security to determine the immigration and work-eligibility status of prospective employees.

The Independent Contractor agrees to certify to the County that they are in compliance with the federal E-Verify program; this includes obtaining written certification from all subcontractors who will participate in the performance of the contract. All subcontractor certifications must be kept on file by the general contractor and made available to the state and/or the County upon request. The Sumter County Board of County Commissioners reserves the right to take action against any contractor deemed to be non-compliant; potential actions may include, but are not limited to, cancellation of the contract and/or suspending or debaring the contractor from performing services for the County.

NOW, THEREFORE, the parties agree as follows:

1. That certain Agreement between the parties dated October 1 2010, is hereby extended to October 1 2013, using the same fee schedule, terms and conditions as the initial term.
2. That certain Agreement between the parties shall include compliance with the federal E-Verify program.

## AGREEMENT BETWEEN OWNER AND CONTRACTOR

This Agreement, made and entered into the first day of October 2010, by and between Sumter County, a political subdivision of the State of Florida, (hereinafter referred to as the "COUNTY") and Page Dixon Chandler Smith, LLC (hereinafter referred to as the "CONTRACTOR") under seal for residential and commercial plan review and inspection services, for Sumter County, (hereinafter referred to as "THE COUNTY"), and the Owner and the Contractor hereby agreeing as follows.

### WITNESSETH

In consideration of the mutual covenants and promises contained herein, COUNTY and CONTRACTOR (the "Parties") hereto agree as follows:

#### Section 1 - Term

This Agreement shall be deemed to commence upon issuance of a Purchase Order, and shall continue until terminated by either party or by October 1, 2011 with an option to renew for two additional one year periods.

#### Section 2 - Scope of Services

CONTRACTOR will provide residential and commercial plan review for compliance with the Florida Building Code, State Statutes, and Sumter County Ordinances, and/or residential and commercial inspection for compliance with the Florida Building Code, State Statutes, and Sumter County Ordinances. Services will be on an as needed basis to be determined by the Building Official or his designee. Work will be performed in accordance with generally accepted professional standards.

#### Section 3 - Compensation

For the Services to be performed, the COUNTY agrees to pay the CONTRACTOR according to Exhibit "A" attached hereto and made a part of. The hourly fixed fee rates listed includes all expenses. No mileage or wages shall be paid for travel to and from inspection locations. Invoices must be kept current for services to continue.

#### Section 4 - Laws, Permits and Regulations

Prior to the performance of any work hereunder, the CONTRACTOR shall obtain and pay for all licenses as required for performing the services of this Agreement, CONTRACTOR shall at all times comply with all appropriate laws, regulations and ordinances applicable to the services provided under this Agreement.

#### Section 5 - Non-Assignment

The CONTRACTOR shall not assign, sublet, or subcontract all or any part of this Agreement without prior written consent of the COUNTY, which consent shall not be reasonably withheld.

**Section 6 - Notices**

Except as otherwise provided herein, all notices and other communications provided for hereunder shall be in writing and sent by certified mail, return receipt requested, or by hand delivery, and shall be deemed effective if mailed when deposited in a United States Postal Service mailbox with postage prepaid or if hand delivered, when personally handed to the Party to whom the notice or other communication is addressed, with signed proof of delivery, The **COUNTY'S** and the **CONTRACTOR'S** representatives for notice purposes are:

**Section 7 - Amendments**

This Agreement may only be amended by mutual written agreement of both Parties.

**Section 8 - Indemnification**

The **CONTRACTOR** shall indemnify and hold harmless the **COUNTY**, its officers, employees, and agents from all suits, claim, or actions of every name and description brought against the **COUNTY** based on personal injury, bodily injury (including death) or property damages received or claimed to be received or sustained by any person or persons arising from or in connection with any negligent act or omission of the **CONTRACTOR** or its employees, officers, or agents in performing the services set forth herein.

**Section 9 - Insurance**

During the term of this Agreement the **CONTRACTOR** shall procure and maintain professional liability, errors and omission insurance and provide a Certificate of Insurance naming the Sumter County BOCC as Additional Insured for the following with minimum limits of Insurance coverage as listed:

General Liability	\$1,000,000 each, 2,000,000 aggregate
Automobile Liability	\$1,000,000
Professional Liability	\$2,000,000
Workman's Compensation	\$100,000 each accident 500,000 each disease

### **Section 10 – Independent Contractor**

In the performance of this Agreement, the **CONTRACTOR** will be acting in the capacity of an “independent contractor” and not as an agent, employee, partner, joint venture, or associate of the **COUNTY** and as such, shall have no authority to bind the County. However, with regard to the actual inspection services to be performed by the **CONTRACTOR**, **CONTRACTOR** shall have the limited authority under County Codes and regulations to render inspections and make findings as provided in FL Statute Section 553.791 which will be binding on the County unless done in violation of such codes and regulations or in violation of Florida law. The **CONTRACTOR** shall be solely responsible for the means, methods, techniques, sequences, and procedures utilized by the **CONTRACTOR** in the full performance of this Agreement as well as all expenses and costs incurred by **CONTRACTOR**.

### **Section 11 – County Responsibility**

The **COUNTY** will notify the **CONTRACTOR** in writing, within thirty (30) calendar days of any change in the service.

### **Section 12 – Default/Termination**

This contract may be terminated without cause, by either party, by providing the other party not less than thirty (30) calendar days’s notice following a thirtieth (30) calendar day opportunity for the **CONTRACTOR** to cure the deficiency in the notice of termination.

### **Section 13 – Timely Performance**

All work will commence upon authorization from the County’s representative. All work will proceed in a timely manner without delays.

### **Section 14 – Claims and Disputes**

All claims, disputes, and other matters in question arising out of, or relating to, this agreement or the breach thereof shall be resolved in the County or Circuit Court of Sumter County, Florida, and all parties hereto specifically waive any “venue privileges” they may have in any other jurisdiction. The prevailing party in any litigation arising out of this agreement shall be entitled to recover from the losing party all cost and expenses, including reasonable attorney’s fees, at the trial court and appellate court level, incurred by the prevailing party in enforcing its rights hereunder, this provision not to be construed as a waiver of the sovereign immunity of Sumter County.

### **Section 15 - County Status**

**COUNTY** shall schedule the contractor’s employees for meeting daily workloads. **CONTRACTOR** shall hold the staffing and equipment needs of **THE COUNTY** as first priority on a daily basis.

### **Section 16 – Access to Data/Software**

**COUNTY** agrees to provide access to building permit data needed by **CONTRACTOR** to fulfill its inspection obligations, and to provide the necessary licenses of the permitting software used by **COUNTY** for building permit inspections, without cost to the **CONTRACTOR**.




