**AMENDMENT  
TO  
AGREEMENT FOR APPLICATION HOSTING AND TECHNOLOGY  
SUPPORT SERVICES**

This Amendment to Agreement for Application Hosting and Technology Support Services (this "Amendment") is made and entered into by and between Sumter County Fire & EMS with offices located at 7375 Powell Road, Suite 129 Wildwood, FL 34785 ("Customer") and ACS GOVERNMENT SYSTEMS, INC. with offices located at 8260 Willow Oaks Corporate Drive, Fairfax, VA 22031 ("ACS"), referred to individually as "Party" or collectively as "Parties."

WHEREAS, the Customer and ACS executed that certain Agreement for Application Hosting and Technology Support Services dated as of October 1, 2012 (the "Agreement"); and

WHEREAS, the Customer and ACS desire to modify the Agreement to add certain modules Customer receives as Services under the Agreement;

NOW, THEREFORE, in consideration of the mutual obligations set forth herein, the Parties mutually agree to amend the Agreement as follows:

1. The "Modules" table on page 1 of the Agreement and the related Modules table in Exhibit B – Applicable Charges shall be modified as of the effective date of this Amendment to indicate the availability of the "Staff Scheduling" as "Yes."

2. The Yearly Fee payable by Customer to ACS as set forth under "Price" on page 1 of the Agreement and under the Payment Schedule table in Exhibit B – Applicable Charges shall be increased from \$7,246 to \$8,913.31 for each remaining year of the Agreement, beginning with Year 2.

3. All terms and conditions of the Agreement, except as expressly amended herein, shall remain in full force and effect.

4. This Amendment shall be effective on November 1, 2012.
