HISTORY/FACTS/ISSUES:

The purpose of this budget amendment is to transfer \$12,500 from General Fund to Fund 155 - Sumter Fire Impact Fees for the purpose of establishing a budget for Sumter Fire Impact Fee Waivers. The Board of Sumter County Commissioners approved modification of the Sumter Fire Rescue Impact Fee Ordinance on October 13, 2009 allowing waivers of these Impact Fees for Exempt Non-Profit Corporations with reimbursement of waived fees to the Impact Fee Funds from the General Fund.
