

Please accept this as Sumter County Transit's formal request for an extension of the above referenced Joint Participation Agreement (JPA) through February 28, 2011. The requested extension will provide for continued operation of the North Villages Shuttle Route through the start-up period of our recently funded Wildwood Shuttle Route to begin July 1, 2010. The Wildwood Shuttle will interconnect with all three Villages Shuttle Routes via transfer at the new Sumter County Government Center in Wildwood. This will allow for continued ridership growth of the Villages Shuttles from individuals in the greater Wildwood area wishing to access employment, services and shopping opportunities located within The Villages.

The requested extension will also help develop the initial ridership of the Wildwood Shuttle from Villages Shuttle passengers needing to access destinations in the greater Wildwood area. Our goal with the requested JPA extension is to achieve ridership levels on the Villages Shuttle Routes by March 1, 2011, that will help sustain the continued operation of these resources into the future. A request for time extension **must** include the extension date, reasons for the extension as well as a schedule for completion of the project.
