

AN ORDINANCE CREATING THE SUMTER COUNTY ENTERPRISE ZONE DEVELOPMENT AGENCY; SETTING FORTH TERMS OF MEMBERS; TERMS OF OFFICE; COMPENSATION; PROVISIONS FOR REMOVAL; MEMBER ACTIONS; STAFFING; POWERS OF THE BOARD; PROPERTY ACQUISITION AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Sumter County, Florida, and the city councils of the cities of Webster, Coleman and Center Hill have adopted resolutions supporting the creation of an enterprise zone development agency, and

WHEREAS, the next step in the creation of such an agency is the adoption of an ordinance pursuant to Fla. Stat. Sec. 290.0056,

NOW, THEREFORE, be it ordained by the board of county commissioners of Sumter County, Florida, as follows:

1. There is hereby created a public body corporate and politic to be known as the "Sumter County Enterprise Zone Development Agency.

2. The board of county commissioners shall appoint a board of commissioners to the Sumter County Enterprise Zone Development Agency consisting of not fewer than eight or more than thirteen members. The board of commissioners shall be known as the enterprise zone development agency board. The members shall consist of at least one representative from each of the following: the local chamber of commerce; local financial or insurance entities; local businesses and where possible, businesses operating within the nominated area; the residents residing within the nominated area; nonprofit community-based organizations operating within the nominated area the regional workforce board; the local code enforcement agency; and the local law enforcement agency. The provisions of Fla. Stat. Sec. 290.0056(2) shall be followed in making the appointments.

3. The term of office of the commissioners shall be for 4 years, except that, in making the initial appointments, the board of county commissioners shall appoint two members for terms of 3 years, two members for terms of 2 years, and one member for a term of 1 year. The remaining members shall serve for terms of 4 years. A vacancy occurring during the term shall be filled for the unexpired term. The board of county commissioners shall designate a chair and vice chair from among the commissioners.

4. A commissioner shall receive no compensation for his or her services but is entitled to the necessary expenses, including travel expenses, incurred in the discharge of his or her duties. Each commissioner shall hold office until a successor has been appointed and has qualified. A certificate of the appointment or reappointment of any commissioner is conclusive evidence of the due and proper appointment of the commissioner.

5. The board of county commissioners may remove a commissioner as set forth in Fla. Stat. Sec. 290.0056(7).

6. The enterprise zone development agency board shall have the powers and responsibilities as set forth in Fla. Stat. Sec. 290.0056(8) and shall comply with all of the provisions of Chapter 290, Fla. Stat. applicable to such agencies. The powers of the agency shall be exercised by the commissioners. A majority of the commissioners constitutes a quorum for the purpose of conducting business and exercising the powers of the gency and for all the other purposes.

7. This ordinance shall take effect as provided by law.

History

Florida established one of the first Enterprise Zone programs in the country in 1982. In 1994, the program changed significantly when the Florida Legislature passed the Florida Enterprise Zone act of 1994. The 1994 act was based primarily on the federal government's Empowerment Zones and Enterprise Communities programs. At this time all existing zones were repealed and a new application and designation process were established.



The application process required the local government to establish a strategic plan, form a local Enterprise Zone Development Agency, and submit a specific map showing the zone's boundaries. The applications were submitted during the summer of 1995 and 19 zones were designated on July 1, 1995.

Subsequently, the Florida Legislature amended Florida Statutes to allow for boundary changes, incentive changes, and the addition of 36 enterprise zone designations. The 1994 act established a repeal date of December 31, 2005.

In 2005, the Florida Legislature extended the Enterprise Zone program for ten years and provided existing enterprise zones an opportunity to have their zones re-designated with boundary amendments.

Administration

The Governor's Office of Tourism, Trade, and Economic Development (OTTED) administers the Florida Enterprise Zone Program. OTTED is responsible for overseeing the activities of the local enterprise zones and providing them with technical assistance and information. OTTED has been authorized by the Florida Legislature to review and approve eligible enterprise zone application packages. OTTED receives progress reports from local enterprise zones as well as reports from the Florida Department of Revenue and prepares an Annual Report to the Governor and the Florida Legislature.

Enterprise Florida plays an important role in marketing the Enterprise Zone program to existing businesses within a zone or to those who are looking to locate in a zone. Enterprise Florida has also taken active roles in proposing Legislation that will improve the program and enhance the economy of Florida as a whole. Enterprise Florida works with OTTED in developing zone approval guidelines and determining which communities would qualify for a zone designation.

At the local level an enterprise zone is governed by an Enterprise Zone Development Agency. This agency oversees the implementation of the strategic plan and makes important decisions concerning the zone. The Enterprise Zone Development Agency also appoints a local enterprise zone coordinator that maintains the day-to-day operations of the zone. This key contact for the zone answers questions and distributes materials to businesses, OTTED, and the local government. The local coordinator is responsible for verifying enterprise zone addresses. All tax incentive applications must be certified at a local office before the applications are sent to the Department of Revenue to be processed.

The Florida Department of Revenue is responsible for processing all enterprise zone tax incentive applications. Representatives from the Department of Revenue provide technical assistance on

the eligibility requirements to businesses and to local enterprise zone coordinators.

Urban and Rural Designations

Because of the diversity in the population and economy throughout the state of Florida, the Enterprise Zone program is designed to accommodate both rural and urban areas. Because rural areas do not attract and retain the same types of businesses that urban areas do, rural Enterprise Zones are given different tax credits through the various incentives.

Listed below are the ways that an Enterprise Zone gets a rural classification:

- Nominating county has a population of 75,000 or less
- Nominating county has a population of 100,000 or less and is contiguous to a county with a population of 75,000 or less
- Nominating municipality is located in a county with a population of 75,000 or less
- Nominating municipality is located in a county with a population of 100,000 or less and is contiguous to a county with a population of 75,000 or less

Federal Enterprise Communities and Empowerment Zones

The Enterprise Zone program operates at both the state and federal levels. Almost every state has some form of an Enterprise Zone program, however, each have their own agendas and incentives to offer. The federal government also has its own form of the program. The federal government has designated a total of 172 Enterprise Communities and Empowerment zones across the US. These designations are based on criteria including population, poverty rates, and economic distress. This programs provides funding to the Community or Zone for a 10 year period. These funds are used for economic revitalization throughout the communities.

Although these communities are designated by the federal government they are also recognized in the Florida Enterprise Zone program. They receive their funding through the federal government as well as offer the state incentives to the businesses within the communities.



EXECUTIVE SUMMARY

INTRODUCTION

In accordance with section 290.014 (2), Florida Statutes, this annual report of the Florida Enterprise Zone Program is submitted to the Governor, the Speaker of the House of Representatives, and the President of the Senate. This report summarizes the results of the Florida Enterprise Zone Program during the timeframe of October 1, 2008, through September 30, 2009.

This report is based on information provided by the fifty-six Enterprise Zone Development Agencies and the Florida Department of Revenue. The purpose of this document is to examine the impact of the program and monitor the use of state and local incentives.

RESULTS FOR 2008/2009

During the third year of the Florida Enterprise Zone Program, as revised in 2005, the following activity levels were reported:

3,104 new businesses moved into or were created in enterprise zones;
9,073 new jobs were created by businesses located in enterprise zones; and
11,708 businesses received assistance from Enterprise Zone Coordinators.

\$45,351,441 state tax incentives were approved by the Department of Revenue;
\$11,577,451 local incentives were provided by the local governing bodies; and
\$56,928,892 total of state and local incentives were awarded.

State approved incentives increased by \$4,991,903 as compared to the prior period (\$45,351,441 in 2008/2009 versus \$40,359,538 in 2007/2008).

During the most current reporting period there were 385 more businesses created (3,104 versus 2,719), and 527 fewer jobs created than during the prior period (9,073 versus 9,600).

Local governments administering the fifty-six enterprise zones received a substantial amount of federal and state support to supplement their revitalization efforts. Local governments received more than \$50-million of funding from federal and state agencies during the 2008/2009-time period.

COMMUNITY CONTRIBUTION TAX CREDIT PROGRAM

The Office of Tourism, Trade, and Economic Development (OTTED) reported that 15 (fifteen) new sponsors were approved to participate in the Community Contribution Tax Credit Program during the reporting period.

Tax credits worth \$14 million (representing 308 donations) were also approved during the reporting period.

LEGISLATIVE CHANGES

During the 2009 Legislative Session, the Florida Legislature approved legislation that provided the City of Ocala an opportunity to submit an Enterprise Zone Application Package.

BACKGROUND

Florida established one of the first enterprise zone programs in the country in 1982 to encourage economic growth and investment in distressed areas by offering tax advantages to businesses willing to make such an investment. An Enterprise Zone is a specific geographic area targeted for economic revitalization. Currently, the state has designated 56 enterprise zones in Florida.

The Florida Enterprise Zone Program offers businesses located in enterprise zones corporate and sales tax credits for hiring residents of the zones. Sales tax refunds are offered to businesses located in the zone that purchase building materials and business equipment for use in the zone. Corporate tax credits are available to new and expanding businesses that locate or expand their facilities in a zone. In some zones, a sales tax exemption on electrical energy is available to new businesses locating there. In addition to these state incentives, local governments also provide a number of incentives to attract new businesses, as well as to help existing businesses expand.

In 1994, the Florida Legislature passed the Florida Enterprise Zone Act of 1994, which significantly revised the existing Enterprise Zone Program. As a result, the existing zones were repealed on December 31, 1994, and parameters were established for designation of new zones. Administrative responsibilities of the program were transferred from the Department of Community Affairs to the Department of Commerce. The jobs tax credit eligibility criteria were revised to require both the business and employee to reside within an enterprise zone.

During the summer of 1995, local governments completed and submitted competitive applications for new Enterprise Zone designations. The application process was patterned after the Empowerment Zone/Enterprise Community programs offered by the federal government. On July 1, 1995, nineteen new Enterprise Zones were designated in urban and rural communities throughout the state.

In 2005, the Florida Legislature extended the program for ten years and provided existing enterprise zones an opportunity to have their zones be re-designated (with boundary amendments).

Effective January 1, 2006, OTTED approved 53 Enterprise Zone Re-designation Application Packages. These 53 enterprise zones will be in effect until December 31, 2015.

Subsequently, the Florida Legislature authorized and OTTED approved an enterprise zone in the following jurisdictions: Lakeland, Levy County, Sumter County and Ocala. These enterprise zones will be in effect until December 31, 2015.

IMPACT OF THE PROGRAM

ENTERPRISE ZONE DEVELOPMENT AGENCIES

All counties or municipalities nominating an area for designation have been required to establish an Enterprise Zone Development Agency. Please refer to see Appendix A (pages 18 - 27) for the most current list of these agencies.

Each governing body appointed a board of commissioners with at least eight, but not more than thirteen, and were encouraged to appoint members that represented the following entities: the local chamber of commerce; local financial or insurance entities; businesses operating within the nominated area; residents living in the nominated area; nonprofit organizations operating within the nominated area; the local private industry council; the local code enforcement agency; and the local law enforcement agency.

Enterprise Zone Application Packages are required to include an Enterprise Zone Development Plan (Plan). At a minimum, the Plan must address the following:

- 1) the goals of the revitalization efforts;
- 2) a description of the area's coordinated efforts for revitalization;
- 3) a description of the area's poverty and general distress;
- 4) verification that local organizations participated in the planning process;
- 5) a commitment from the governing body to enact fiscal and regulatory incentives;
- 6) an identification of the private resources available in the nominated area;
- 7) provide an indication of how the local and state resources would be utilized;
- 8) the identification of funding requested under any state or federal program; and
- 9) the identification of baseline data and benchmarks for implementing the plan.

OTTED maintains a copy of each EZDA Annual Report that includes information regarding accomplishments and progress concerning the implementation of the strategic plan or measurable goals, and any updates to their strategic plan or measurable goals.

In addition to implementing the goals and objectives of their Plan, each Agency is required by section 290.0055 (9), Florida Statutes, to perform the following zone related activities:

- review, process and certify applications for state tax incentives pursuant to ss. 212.08 (5), (h) and (15); 212.096; 220.181; and 220.182;
- provide assistance to businesses and residents within the zone; and
- promote the development of the zone.

An Agency Coordinator, who is responsible for the day-to-day operations of the Agency, normally performs these activities. Typically, the Agency Coordinator is an employee of a local governmental agency, chamber of commerce or an economic development organization.

OTTED ACTIVITY LEVEL

Throughout the reporting period, OTTED provided technical assistance to existing enterprise zones by conducting local workshops and training sessions. In addition, OTTED provided the public with information and referrals to local Enterprise Zone Development Agencies and other state agencies.

ENTERPRISE ZONE INCENTIVES

The Florida Enterprise Zone Program includes financial incentives which are offered to businesses to encourage private investment and increase employment opportunities for enterprise zone residents. These incentives are available to businesses that are located within a designated zone. A statutory reference is provided for each incentive.

The approved amounts of these incentives are summarized in a table on pages 7 - 9 of this report.

- **Enterprise Zone Jobs Tax Credit (Sales & Use Tax):** Businesses located in a zone, who collect and pay Florida sales and use tax, are allowed a monthly credit against their sales tax due on wages paid to new employees who have been employed for at least three months and are residents of a Florida enterprise zone or a rural county (s. 212.096, FS).
- **Enterprise Zone Jobs Tax Credit (Corporate Income Tax):** Businesses located in a zone who pay Florida Corporate Income Tax are allowed a corporate income tax credit for wages paid to new employees who have been employed for at least three months and are residents of a Florida enterprise zone or a rural county (s. 220.181, FS).
- **Enterprise Zone Property Tax Credit (Corporate Income Tax):** New or expanded businesses located in a zone are allowed a credit on their Florida Corporate Income Tax equal to 96 percent of ad valorem taxes paid on the new or improved property (the assessment rate varies by county) (s. 220.182, FS).
- **Sales Tax Refund for Building Materials Used in an Enterprise Zone:** A refund is available for sales taxes paid on the purchase of building materials used to rehabilitate real property located in a zone (s. 212.08(5)(g), FS).
- **Sales Tax Refund for Business Machinery and Equipment Used in an Enterprise Zone:** A refund is available for sales taxes paid on the purchase of certain business property, (e.g. tangible personal property such as office equipment, warehouse equipment, and some industrial machinery and equipment), which is used exclusively in a zone for at least three years. The minimum purchase price of equipment is \$5,000 per unit. (s. 212.08(5)(h), FS).
- **Sales Tax Exemption for Electrical Energy Used in an Enterprise Zone:** A 50 percent sales tax exemption is available to qualified businesses located in a zone on the purchase of electrical energy. The exemption is only available if the municipality in which the business is located has passed an ordinance to exempt qualified enterprise zone businesses from 50 percent of the municipal utility tax (s. 212.08(15), FS).
- **Community Contribution Tax Credit Program:** Businesses located anywhere in Florida are allowed a 50 percent credit on Florida Corporate Income Tax or Insurance Premium Tax as well as a sales tax refund for eligible donations made to approved community development projects (s. 212.08 (5) (p), 220.183 & s. 624.5105, FS).

ENTERPRISE ZONE INCENTIVES

(CONTINUED)

The following state incentive amounts were approved by the Florida Department of Revenue during the period between October 1, 2008, and September 30, 2009.

The amount of state financial incentives of \$45,351,441 for this reporting period represents an 11-percent increase from the \$40,359,538 of state tax incentives approved in the 2007/2008-time period.

COMMUNITY CONTRIBUTION TAX CREDIT PROGRAM

The Community Contribution Tax Credit Program was established by the Florida Legislature (sections 212.08 (5) (p), 220.183 and 624.5105, Florida Statutes) to encourage private sector participation in revitalization projects located within enterprise zones or housing projects for low - income persons.

The program offers a tax incentive (a corporate income tax credit, insurance premium tax credit or a sales tax refund) equal to 50 percent of the amount donated to sponsors who have been approved to participate in the program.

OTTED is responsible for administering the program by reviewing sponsor's project proposals and tax credit applications. Presently, 144 sponsors have been approved to participate in the program.

Eligible sponsors include: Community Development Corporations, Neighborhood Housing Services Corporations, Local Housing Authorities, Community Redevelopment Agencies, Enterprise Zone Development Agencies, Units of Local and State Governments, School Boards and Non-profit Corporations affiliated with community and economic development efforts.

Eligible projects include: construction, improvement, or rehabilitation of housing, commercial, industrial, or public facilities. Also included are projects that promote entrepreneurial or job development opportunities for low-income persons.

The Florida Legislature has allocated a total \$14.0 million of tax credits for the state fiscal year beginning on July 1, 2009. Projects that provide home ownership opportunities were allocated \$10.5 million of tax credits while all other projects were allocated \$3.5 million of tax credits.

The Community Contribution Tax Credit Program is scheduled to expire on June 30, 2015.

LOCAL INCENTIVES

In addition to those incentives provided by the state, some local governments offer the following incentives as part of their Enterprise Zone Development Plan:

- Reduction of occupational license fees
- Ad valorem tax exemption on improved property
- Local option economic development property tax exemption
- Utility tax abatement
- Facade/Commercial Rehabilitation Grants (Loans)
- Local funds for capital projects
- Reduced building permit fees or land development fees
- Reduction of specific local government regulations in the area

The amount of **\$11,577,451** worth of local incentives provided during this reporting period represents a decrease of **\$10,893,150** from the **\$22,407,601** worth of incentives provided by local governments in the previous reporting period.
