A request for time extension must include the extension date, reasons for the extension as well as a schedule for completion of the project.

All persons employed by the Local Agency during the term of the Contract to perform employment duties within Florida; and (b.) 

Re: Extension requests of four Joint Participation Agreements

Dear Ms. Adamson:

Sumter County Transit is requesting an extension of the Joint Participation Agreement (Contract Number APA52) until December 31, 2011. The program provided over 1800 trips between October 1, 2008 and September 30, 2009. In its second year, the program provided more than 5200 trips between 10/1/2009 and 9/30/2010. We now have 62 qualified registrants and we average 28 of them using the service each work day. The demand for this very successful program continues to increase at a steady pace.

We are also requesting an extension of the JPA's that are known as the North (AP 405), Central (AP 407) and South (AP 406) Villages Shuttle through June, 30, 2011. With the recent route revision that has been approved by the F.D.O.T., we expect to provide a service that will greatly increase ridership and eventual regionalization opportunities. Additionally with the implementation of our newest shuttle in Wildwood on 3/1/2011 we anticipate nearly full north to south access for our passengers via our shuttle system. Obtaining the extensions to the maximum time permitted will greatly assist us in the accomplishment of our goals.
