RESOLUTION OF THE LAKE~SUMTER METROPOLITAN PLANNING ORGANIZATION (MPO) ADOPTING THE FY 2016/17 THROUGH FY 2034/35 LIST OF PRIORITY PROJECTS AND AUTHORIZING TRANSMITTAL OF THE NEW FUNDING PRIORITIES TO THE FLORIDA DEPARTMENT OF TRANSPORTATION

WHEREAS, the Lake~Sumter Metropolitan Planning Organization (MPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for Lake-Sumter Planning Area; and

WHEREAS, Florida Statutes 339.175; 23 U.S.C. 134; and 49 U.S.C. require that the urbanized area, as a condition for the receipt of federal capital or operating assistance, has a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

WHEREAS, Florida Statutes 339.175(8)(a), requires that the MPO is responsible for developing, annually, a list of project priorities and a transportation improvement program (TIP); and

WHEREAS, the Florida Department of Transportation has established a deadline of August 1 for the submittal of new project priorities for funding from state FY 2016/17 through FY 2034/35, with said priorities serving as a basis upon which FDOT District 5 makes funding decisions relative to the FDOT five-year Work Program; and

WHEREAS, the Lake~Sumter MPO, serving the role of prioritizing all federal-aid roadways, also has prioritized county transportation projects for the purpose of communicating to each county the regional county transportation needs within the MPO Area.

NOW, THEREFORE, BE IT RESOLVED by the Lake~Sumter MPO:

1. The FY 2016/17 - FY 2034/35 List of Priority Projects is consistent with the MPO's 2035 Long Range Transportation Plan, which was adopted Dec. 8, 2010; and


2. The FY 2016/17 - FY 2034/35 List of Priority Projects is hereby endorsed and adopted; and
