





Selection Committee meeting held on July 19, 2011.

The meeting started at 10:00am in Room 208 of The Villages Sumter County Service Center, 7375 Powell Road, Wildwood, FL 34785.

Richard Cobb, Facility Maintenance, Jackey Jackson, Public Works, and Bruce Root, Parks & Recreation were present as Selection Committee members.

Tina Chavez was present to represent county staff.

Representatives from two proposal firms were present (sign in sheet attached).

Tina stated this meeting is held for the Selection of Vendor for Janitorial Services. The Selection Committee's recommendation to contract for services will go the Sumter County Board of County Commissioners on July 26, 2011.

Tina then turned the meeting over to the Selection Committee.

Due to the listing of various contract amounts (monthly verses annual rates) within the proposals, the selection committee members reviewed spreadsheets prepared by Tina and Richard. Each person prepared a list figuring the annual service amount for each vendor, based on cost provided in RFPs (documents attached). Selection committee discussed each proposal submitted in not special order:

USSI – committee members were concerned that the low proposal amount would not place the firm in a competitive service standing and committee removed RFP from consideration.

BARO – committee members were concerned that the low proposal amount would not place the vendor in a competitive service standing and committee removed RFP from consideration.

W&G – committee members felt that proposal was too high for our scope of work. Committee removed RFP from consideration.

Oxford – committee members felt that the proposal was too high for our scope of work. Committee removed RFP from consideration.

JMC – proposal acknowledge termination of prior contract with Sumter County, due to prior service level. Committee removed RFP from consideration.

Gibbs – company only acknowledged four years of operation, no staffing level submitted, and packet appeared incomplete. Committee removed RFP from consideration.

Grosvener – No references provided, no level of staffing (staff per building) provided, no figures for steam cleaning given on pricing spreadsheet – packet considered incomplete and committee removed RFP from consideration.

GCC – List customer over 15 years, but no letter of references, no staffing levels provided packet was not impressive

American – No level of staffing, had letter of references, long term work with other county, QC program and safety plan in place.

ABC – did not list sq. ft. and pricing for other jobs, level of staffing not provided. Current provider - doing a good job and quick to respond to calls. No program of inspection

Nelsonic – confusing level of staffing did not include all Sumter Buildings in report, they tend to repeat information provided by Sumter. Committee removed RFP from consideration.

ISS – National company, no reference letter but received high approval rating(s) from customer, no staffing level.

D&A- Middle of pricing range, has over 25 years experience, no letters of reference, included level of staffing, good inspection program, safety program in place, corrective action program, e-verify ability, and high rise window cleaning capability.

Sunshine – 30 years experience, current clients are in high (customer) service buildings, no staffing level, has letter of reference and disaster plan in place.
