The source of our water is groundwater from a well located in the community. The well draws from the Floridan Aquifer, one of the world's most protected sources. Our water is chlorinated for disinfection purposes. In 2015, the Florida Department of Environmental Protection performed a Source Water Assessment on our system and a search of the data sources indicated no potential sources of contamination near our well.
