

Amendment #5
Sumter County Fire and Security Services Agreement

This agreement amendment is made and entered into this 23rd day of March 2021, between the Board of County Commissioners of Sumter County Florida, 7375 Powell Road, Wildwood, Florida 34785 (County) and A-Line Fire & Safety, Inc. 117 South 12th Street, Leesburg, Florida 34748 (Vendor).

WHEREAS, the parties executed an original agreement dated September 25, 2018 for RFP 031-0-2018/RS Sumter County Fire and Security Services;

WHEREAS, the County wishes to add the Sumter County Detention Center (Jail) Foxtrot – F Building, West Wildwood Fire Station #33, and Back-up 911 Building in Bushnell for various certification, monitoring, cleaning and inspection services. All other terms and conditions will remain the same.

NOW, THEREFORE, the parties agree as follows:

1. That the certain agreement between the parties originally dated September 25, 2018 is hereby amended to add the Sumter County Detention Center (Jail) Foxtrot – F Building for certification, monitoring, backflow, and inspection services. Add West Wildwood Fire Station #33 for certification, monitoring, inspection and hood cleaning services. Add Back-up 911 Building for certification and monitoring services.
2. Firm shall, at all times, comply with the Florida Public Records Law, the Florida Open Meeting Law and all other applicable laws, rules and regulations of the State of Florida.

4. Except as expressly modified by Amendment #1, Amendment #2, Amendment #3 and Amendment #4, all other terms and conditions of the original Agreement remain in full force and effect for the term of the Agreement.
