A RESOLUTION OF THE BOARD OF SUMTER COUNTY  
COMMISSIONERS CLOSING AND VACATING ROAD,  
RIGHT-OF-WAY OR EASEMENT UPON THE PETITION OF  
NICHOLS CEMETERY ASSOCIATION, INC.

WHEREAS, NICHOLS CEMETERY ASSOCIATION, INC.

has filed a Petition to close a certain road, right-of-way or easement in  
Sumter County, Florida, and

WHEREAS, notice of public hearing on said Petition was duly published in  
the Sumter County Times on Dec. 23, 30, 1982 & Jan. 6, 19 83 and a public  
hearing was held on the Petition on January 11, 19 83,  
and there being no objections to the Petition, and

WHEREAS, this Board upon consideration of the Petition and all evidence  
presented at the hearing, has determined that the road, right-of-way, or  
easement described in the Petition should be closed and vacated, and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
SUMTER COUNTY, FLORIDA, as follows:

1. The Board of County Commissioners of Sumter County, Florida, pursuant  
to Florida Statute Chapter 336 and Sumter County Ordinance 82-2, does hereby  
close and vacate all that portion of that certain road, right-of-way or  
easement in Sumter County, Florida, described as follows:

That portion of County Road No. 246 lying from the  $\frac{1}{2}$  miles post on the  
west side of Section 17, Township 18 South, Range 22 East,  
northeasterly to the fence surrounding the cemetery plots of  
Nichols Cemetery.

2. A copy of this Resolution shall be spread among the minutes of this  
Board and a Notice of the adoption of this Resolution shall be published one  
time in the Sumter County Times. Proof of Publication of said Notice and a  
certified copy of this Resolution shall be recorded in the Official Record  
Books of Sumter County, Florida, all at the expense of the Petitioner.
