A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SUMTER COUNTY, FLORIDA, AUTHORIZING AND APPROVING THE TERMS OF THE OFF SYSTEM CONSTRUCTION AND MAINTENANCE AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE STATE ROAD 50 WIDENING PROJECT FROM EAST OF COUNTY ROAD 757 TO EAST OF THE SUMTER/LAKE COUNTY LINE.

WHEREAS, included in the State of Florida Department of Transportation Work Program is Project Financial Management Number (FM#) 435859-4-43/52-01 (State Road 50 from east of County Road 757 to east of Sumter/Lake County line), located in Sumter County, Florida, hereinafter referred to as the "Project", some of which is partially not on the State Highway System; and,

WHEREAS, Sumter County and the State of Florida Department of Transportation (the Department) agree that it is in the best interest of the Department and of Sumter County for the Department to act on behalf of, in the name of, and for the benefit of Sumter County in completing all aspects of any portion of the Project not on the State Highway System, including, but not necessarily limited to (1) the acquisition of real property necessary for the Project to be constructed through voluntary acquisition and through the use of the power of eminent domain, if necessary, to complete this Project as authorized by §336.467, Florida Statutes; and (2) constructing the Project through its completion, and (3) providing Construction Engineering Inspection (CEI) as necessary for the Project.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Sumter County that the Off System Construction and Maintenance Agreement for Project Financial Management Number (FM#) 435859-4-43/52-01 (State Road 50 from east of County Road 757 to east of Sumter/Lake County line), located in Sumter County, Florida is hereby approved; and that Craig A. Estep, its Chairman, is hereby authorized to make, execute, and deliver to the State of Florida Department of Transportation that certain Off System Construction and Maintenance Agreement for Project Financial Management Number (FM#) 435859-4-43/52-01.
