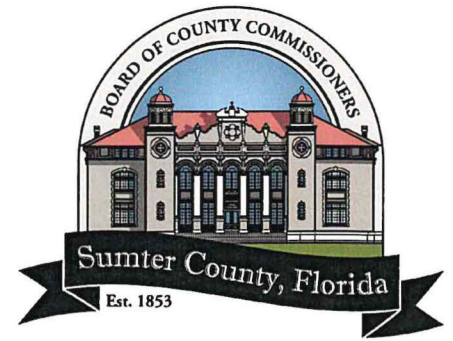

RE: Permitted Internet Café Status Report, December 2022

Sumter County has issued operating permits to thirteen internet café businesses. Three additional businesses filed for operating permits prior to the application deadline.
