
CIVIL RESTITUTION LIEN ORDER

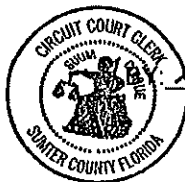

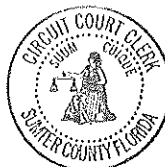
