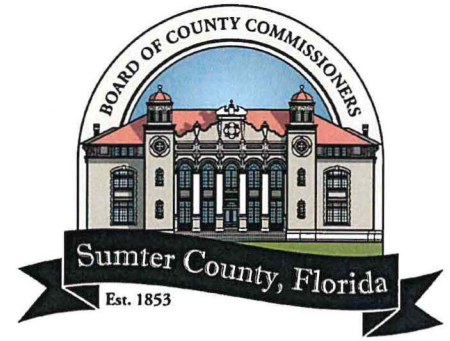

**RE:** Permitted Internet Café Status Report, January 2023

Sumter County has issued operating permits to thirteen internet café businesses. Three additional businesses filed for operating permits prior to the application deadline. One operating permit, OP2022-0002 Fun Time Arcade, was revoked on May 24, 2022, and the operator surrendered the permit on May 31, 2022.
