We are finishing up the paperwork on our end and will be sending it over next week. But, during the review, we came across this excerpt in the NTN Agreement Form:

MEMBER AGENCY WILL PROVIDE

The Member Agency will provide information regarding the organization and applications for use on the NTN website, including organization logos. The Member Agency will also provide links on Member Agency's websites to direct candidates to the NTN website for test sign-up. The Member Agency will also engage in reasonable recruitment and advertising measures to bring candidates both to the NTN website and Member Agency's website for pre-employment purposes.

I just wanted to receive clarification, as this is an agreement form. We are not opposed to having a link for applicants to utilize NTN, but we do not want to make it a hard requirement, nor do we want to give the impression that the applicant is forced to go to the NTN in order to be eligible to apply.

With that, is there a conflict in the wording of the agreement and our intentions?
