

Amendment #1/Extension #1
Sumter County Pavement Management Services Agreement

This contract amendment/extension is made and entered into this 9th day of May 2023, between the Board of County Commissioners of Sumter County Florida, 7375 Powell Road, Wildwood, Florida 34785 (County) and International Cybernetics Company, LP (Vendor), Post Office Box 17246, Clearwater, Florida, 33762.

WHEREAS, the parties executed an original contract effective May 11, 2021.

WHEREAS, the County and Vendor wish to extend the contract through May 10, 2024 under the renewal option.

WHEREAS, the County and the Vendor wish to amend the contract to add language so that other public agencies may seek to piggyback under the same terms and conditions.

NOW, THEREFORE, the parties agree as follows:

1. That the certain contract between the parties originally dated May 11, 2021 is hereby extended to May 10, 2024.
2. The following language will be added to the agreement:

ADDITIONAL SERVICES/PURCHASES BY OTHER PUBLIC AGENCIES

The Vendor by submitting a Proposals/bid acknowledges that other public agencies may seek to “Piggy-Back” under the same terms and conditions during the effective period of any resulting contract services and/or purchases being offered in this Proposals/bid for the same prices and/or terms being proposed. Vendor has the option to agree or disagree to allow contract Piggy-Backs on a case-by-case basis. Before a public agency is allowed to Piggy-Back any contract, the agency must first obtain the Vendor’s approval. Without the Vendor’s approval, the seeking agency cannot Piggy-Back.

3. Vendor shall, at all times, comply with the Florida Public Records Law, the Florida Open Meeting Law and all other applicable laws, rules and regulations of the State of Florida.
4. **IF THE VENDOR HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO THE VENDORS’ DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS AGREEMENT, CONTACT THE CUSTODIAN OF PUBLIC RECORDS AT 352-689-4400, Sumter County Board of County**

5. Except as expressly modified by Extension #1/Amendment #1, all other terms and conditions of the original Agreement remain in full force and effect for the term of the Agreement.
