this Order shall constitute a civil restitution lien, for which let execution issue.

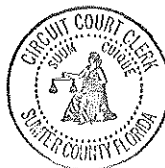
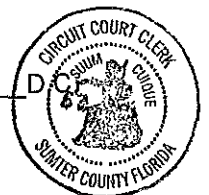
