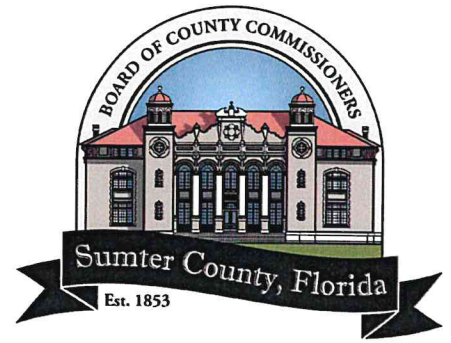

Sumter County hereby gives notice that the Certificate of Approval, as provided in the Sumter County Land Development Code 13-654(b), issued August 7, 2020 to Curaleaf Florida, LLC to establish a medical cannabis dispensary expired as of August 6, 2023. The period of licensure was from August 7, 2020 to August 6, 2023, and a condition of the Certificate of Approval was for Curaleaf Florida, LLC to obtain a premise authorization for a specific operation location. No premise authorization was obtained prior to August 6, 2023. Therefore, as of August 6, 2023 the Certificate of Approval expired.

Pursuant to Section 13-370, you may appeal this determination, within thirty (30) days of receipt of this determination, by filing with the Commission a notice of appeal and a copy of this determination. Such appeal shall be in writing and shall include such information as the date of appeal, grounds upon which the appeal is made and other applicable information.


