Thanks for the conversation earlier this week, and hoping all fared well with the storm in Sumter County....based on our conversation, we understand that due to the recent board action of the Sumter BOCC to not approve increased funding for the FD in FY2024, Sumter is unable to fund/commit to the continued staffing contract with AMR past 9/30/23...our call served as our notification from the County (30-days notice)....based on your communication we will discontinue services as of 10/1, as the contract will expire....additionally you asked about continuing to lease and/or consider purchase our ambulances....AMR is open to continuing to lease the (4) units to Sumter as we currently do today, however given some other immediate asset needs in neighboring FL and GA markets, we are unable to sell or lease any additional assets at this time.....Ed and team have already message the IAEP union as well as the staff regarding the upcoming changes. Appreciate the opportunity to continue to work with Sumter County, and we certainly hope that at some point in the future, we are able to again support in a more meaningful way....please let us know if we need to amend/execute a new agreement.
