**ORDER GRANTING PLAINTIFF'S MOTION FOR JUDICIAL DEFAULT
AGAINST DEFENDANT, THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS
N/K/A LOUELLA JENKINS**

THIS CAUSE having become before this Court upon receipt of Plaintiff's, **SUMTER
COUNTY, FLORIDA**, a political subdivision of the State of Florida, pursuant to Rule 1.500(b)
of the Florida Rules of Civil Procedure, Motion for Judicial Default Against Defendant, The

Unknown Spouse of Rickey Lee Jenkins N/K/A Louella Jenkins, and having reviewed the file and being otherwise duly advised the premises finds as follows:

1. Plaintiff, **SUMTER COUNTY, FLORIDA**, a political subdivision of the State of Florida, acting by and through the Board of County Commissioners, filed its Complaint for Foreclosure against the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS**, on July 11, 2023.

2. A Return of Substitute Service to Judy Ann Cole for The Unknown Spouse of Rickey Lee Jenkins N/K/A Louella Jenkins was filed with the Clerk of the Court on July 27, 2023, under Filing No.: 178396983, showing the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS**, was properly served with the Complaint on July 11, 2023.

3. The Answer from the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS** was due on August 11, 2023.

4. As a result of the failure of Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS**, to timely file an Answer, pleading, or paper to the Complaint for Foreclosure, the Plaintiff filed a Motion for Entry of Clerk's Default against the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS** on August 12, 2023, under Filing No.: 179512509.

5. A Clerk's Default was entered against the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS** on August 16, 2023, under Docket No.: 42 pursuant to Florida Rule of Civil Procedure 1.500.

6. The issuance of a Default Judgment against the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS**, is appropriate due to

the Defendant's failure to respond as required by the aforementioned rule.

Based on the foregoing, it is hereby:

ORDERED AND ADJUGED that default judgment is entered against the Defendant, **THE UNKNOWN SPOUSE OF RICKEY LEE JENKINS N/K/A LOUELLA JENKINS** for failure to plead or otherwise defend as required by law.

It is further ORDERD and ADJUDGED that within five (5) days from the date of e-service of this Order/Judgment, the attorney submitting this Order/Judgment shall furnish a copy of this Order /Judgment to each self-represented party by U.S. Mail, first class, postage paid, and, file a certificate signed by that attorney that delivery of this Order/Judgment has been made as set forth herein.
